CAP CONFERENCE 2018

OAHU Members descend on Capitol Hill to advocate for Affordable Health Insurance

During the week of February 26th forty-three members of the Ohio Association of Health Underwriters attended the National Association of Health Underwriters Annual Capitol Conference in Washington D.C. The annual conference is a great opportunity for attendees to hear about the latest Federal legislative and regulatory actions that are occurring in the health insurance industry. It's also an opportunity for NAHU members to meet with their member of Congress to "weigh-in" on legislative and regulatory issues that affect health insurance agents and the clients they serve.

OAHU members had the opportunity to meet with all Ohio members of Congress and/or their staffs and Ohio's two U.S. Senators, Rob Portman and Sherrod Brown. During our meetings with Senators Brown and Portman OAHU members advocated for the following pending legislation and issues:

- S. 2303 Remove Agent/Broker Commissions from the Medical Loss Ratio to ensure that consumers can continue to access professional independent health insurance agents.
- S. 1908 To ease employer reporting requirements by establishing a new voluntary reporting system which would reduce the number of individuals and amount of information that would be required to be reported.
- Other issues discussed included: Increase flexibility for HSAs, preserve the employer tax exclusion, allow tax credits to be used outside of the Federal Marketplace and allow states to be eligible for funding of new hybrid high-risk pools/reinsurance.

OAHU members also advocated for the following legislation/issues in meetings with Ohio's members of Congress:

NAHU created the President's Triple Crown Program to recognize those members whose individual contributions to NAHU help advance the association's mission. Like baseball's Triple Crown, it recognizes accomplishments in three key areas. However, while baseball's Triple Crown hasn't been won since 1967, NAHU's Triple Crown can be won every year by hundreds of our members. <u>Read</u> More

Reduce 90-day grace period for non-payment of

- premium for individuals receiving premium tax credits to the same 30-day grace period for other covered individuals.
- Allow tax credits to be used outside of the Marketplace if fewer than two choices are offered in a state. (This is a current problem in Ohio)
- H.R. 3919 To ease employer reporting requirements by establishing a new voluntary reporting system which would reduce the number of individuals and amount of information that would be required to be reported.
- Allow COBRA coverage to count as creditable coverage for Medicare beneficiaries just as employer-sponsored coverage does.

The other major portion of Capitol Conference was the opportunity to hear from a wide range of speakers with diverse perspectives on the future of health care and health insurance in our country and also political perspectives from both Republican and Democrat leaders and pundits. Included in the featured speakers were:

- Members of Congress providing their perspectives (and support) for NAHU's Medical Loss Ratio (MLR): Representatives Kurt Schrader (D-OR), Jackie Walorski (R-IN), Billy Long (R-MO) and Senator Chris Coons (D-DE)
- An informative presentation by Peter Lee, Executive Director of Covered California) a state-based exchange that appears to be seeing success with their program.

All in all, NAHU's Capitol Conference is a great opportunity to hear about the latest federal legislative and regulatory activities that directly impact the health insurance agent profession and the consumers you serve. Members of Congress and their staff see first-hand that NAHU members are uniquely qualified to provide the "real world" experiences that consumers and employers face as they attempt to purchase affordable health insurance for their families and employees.


